IT IS NOTIFIED for general information that a Parliamentary By-Election for the Constituency of Ubenide will be held on Saturday, 9th July, 1994.

Voting is compulsory for all electors, unless an elector:-

is absent from Nauru on polling day;

is seriously ill or infirm to the extent that he/she is precluded from attending a polling plance to vote;

(In the case of a woman) is precluded by approaching maternity from attending at a polling place to vote; or

has some other valid and sufficient reason for not voting (to the satisfaction of the Returning Officer).
