COURT FEES RULES 1994

IN EXERCISE of the powers conferred on me by section 58 of the Civil Procedure Act 1972, I hereby make the following rules of Court.

TITLES :

These Rules may be cited as the Court Fees Amendment Rules 1995.

1. The Court Fees Rules 1994 are hereby amended by the 'addition to the fee prescribed therein relating to the grant of probate and letters of Administration or resealing of probate of the following subglauses:

Amount of Fee for proceedings in the Supreme Court.

(c) if the application for probate or letters of administration or the resealing thereof is made in respect of a foreign will or foreign estate under the provisions of the Foreign Trusts Estates and Wills Act 1972.

IN THE MATTER OF THE LEGAL PRACTITIONERS ACT 1973

ORDER UNDER SECTION 11(b) QUALIFICATION OF PLEADERS

PURSUANT to section ll(b) of the Legal Practitioners Act 1973 $\overline{1, \text{ GAVEN}}$ JOHN DONNE, Chief Justice HEREBY PRESCRIBE that the qualification by examination under the said section for admission as Pleaders under the said Act shall be as follows:

- 1. For admission on the Roll of Pleaders of Nauru, a Certificate in Law (Criminal) granted by the University of the South Pacific shall be required to be held by applicants.
- 2. For the right of audience to practice in the District Court a pleader must be the holder of a Certificate in Law (Criminal) of the said University of the South Pacific.
- 3. For the right of audience to practice in the Supreme Court a pleader must be the holder of a Certificate in Law (Criminal) and a Certificate in Law (Civil) of the said University of the Pacific.

This order shall not apply to any person who prior to this day has commenced a course of examinations prescribed in any prior Order and has qualified in part thereunder provided such course is completed in compliance with such prior Order.
