NAURU SUPERANNUATION FUND

The Trustees of the Nauru Superannuation Fund wish to advise Female Officers of the Public Service about the substantial legislative changes effected on or after January 1, 1996 to contribution to the Superannuation Fund by the Superannuation (Amendment) Act 1995. As a result of these changes, the married women are placed on the same basis as males. These changes are stated as under:-

1. The Married woman shall be eligible to contribute to the Fund. A female contributor who marries during her service shall continue to be a contributor to the Fund. She will no longer be deemed to have resigned on the date of marriage.
2. A female officer shall be allowed to contribute in respect of a unit an amount as per column 4 of Table of Contributions set out in the Schedule to Section 24, having regard to the age of the contributor, i.e., as the same rates as males. A copy of Table enclosed for information as Annexure I. However, a female officer who is a current contributor may on or before 1, 1996 elect by notice in writing to make contribution in accordance with column 4 of the abovesaid Table. An election made shall be delivered to the Chairman of the Board in proforma s per Annexure II and once made cannot be retracted. A female officer who does not make an election shall continue to make contributions at the existing rates as per column 5 of the aforesaid Table and her entitlement shall be determined accordingly.
3. All women who join on or after January 1, 1996 do so on the same basis as males- they have no choice.
