NAURU ISLAND COUNCIL ACT 1992 2ND GENERAL ELECTION OF COUNCILLORS.

It is notified for General Information that a General Election of Councillors of the Nauru Island Council will be held on Saturday the 9th of November 1996.

VOTERS' ROLLS:

APPLICATION FOR ENROLMENT/CHANGE OF DISTRICT OF ENROLMENT

A person who on the entitlement date (i.e. between, Saturday the 26th of October 1996, and Saturday the 2nd of November 1996), is resident within a District and enrolled on the existing roll of electors for that District need not apply for enrolment. However, a person who is not less than 20 years of age on the entitlement date mentioned above and who wishes to enrol for a District for the first time and a person who wishes to change his/her District of enrolment has to complete and lodge an application for enrolment in the office of the Returning Officer at Civic Centre, in the prescribed form, obtainable from the office of the Returning Officer during normal office hours.

The voters' rolls will be opened on Friday, 11th of October 1996 and closed at 12.00 noon on Saturday, 19th of October, 1996. Application for enrolment/change of District of enrolment must be lodged at the office of the Returning Officer not later than 12.00 noon on Saturday, the 19th of October, 1996.

VOTING IS COMPULSORY

A person wishing to nominate a candidate for the election shall complete and lodge a notice of candidature in the prescribed form, obtainable form the office of the Returning Officer, after closure of rolls.

The Notice of Candidature will be received at the office of the Returning Officer up to 4 p.m. on Wednesday 23rd of October 1996.

WITHDRAWAL OF CANDIDATURE

A candidate may withdraw a notice of candidature before 4 p.m. on 26th of October 1996.

Saturday the 9th of November 1996.
