# NAURU ISLAND COUNCIL ACT 1992 BY ELECTION FOR THE GROUP OF DISTRICTS COMPRISING THE DISTRICTS OF ANIBARE, IJUW AND ANABAR

It is notified for General Information that a By-Election to elect a Councillor for the group of districts comprising the Districts of Anibare, Ijuw and Anabar will be held on Saturday the 22nd March 1997.

### **VOTERS' ROLLS:**

#### APPLICATION FOR ENROLMENT/CHANGE OF DISTRICT OF ENROLMENT.

A Person who on the entitlement date (i.e a date between Saturday, the 8th of March 1997 and Saturday the 15th of Mach 1997), is resident within a District and enrolled on the Council's existing roll of Electors for that District need not apply for enrolment. However, a person who on the entitlement date mentioned above is not a person referred to above and is not less than 20 years of age; and is a person who is a member of the Nauruan Community ordinarily resident in Nauru; or a person who is a Citizen of Nauru ordinarily resident in Nauru entitled to apply to be enrolled on the Voters' Roll, in respect of his principal place of residence. An application for enrolment of the Voters' Roll or for change of enrolment must be in writing and in the prescribed form (obtainable from the Council Office during normal office hours) and contain the prescribed particulars and be delivered to the Council office not later than 4.00 p.m. on Saturday the 1st of March 1997.

The voters' Rolls will be opened on Monday, the 24th February 1997 (8.00 a.m.) and closed at 4.00 p.m. on Saturday the 1st of March 1997.

#### **VOTING IS COMPULSORY:**

#### **NOMINATION OF CANDIDATES:**

A person wishing to nominate a candidate for the election shall complete, sign and deliver at the Council office a notice a notice of Candidature in the prescribed form, obtainable from the Council office, after closure of rolls.

The Notice of Candidature will be received at the Council office upto 4.00 p.m. on Saturday, the 8th of March 1997.

### WITHDRAWAL OF CANDIDATURE:

A candidate may withdraw a notice of candidature before 4.00 p.m. on Saturday the 8th of March 1997.

#### **DATE OF ELECTION:**

Saturday the 22nd of March 1997.
