## CONSTITUTION OF NAURU CABINET APPOINTMENT UNDER ARTICLE 21

I EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE VINSON DETENAMO, M.P. BEING THE MINISTER FOR INTERNAL AFFAIRS AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU, DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY PRESIDENT KINZA CLODUMAR, M.P FROM THE REPUBLIC.

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, KINZA CLODUMAR, M.P., PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU THE RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:-

THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE PERIOD OF ABSENCES OF HIS EXCELLENCY THE PRESIDENT, THE HONOURABLE KINZA CLODUMAR, M.P, MINISTER FOR ISLAND DEVELOPMENT AND INDUSTRY, CIVIL AVIATION AND EDUCATION, THE HONOURABLE BERNARD DOWIYOGO, M.P, AND MINISTER FOR HEALTH AND YOUTH AFFAIRS, THE HONOURABLE LUDWIG SCOTTY, M.P. FROM THE REPUBLIC.
