# REPUBLIC OF NAURU ANIMALS ACT 1982 ANIMALS (PRESCRIBED FEES) REGULATIONS 1996

In exercise of the powers conferred on it by section 20 of the Animals Act 1982, the Cabinet has made the following Regulations-

# SHORT TITLE

1. These Regulations may be cited as the Animals (Prescribed Fees) Regulations 1996.

#### **COMMENCEMENT**

2. These Regulations shall come into force with immediate effect.

# **INTERPRETATION**

3. In these Regulations, "The Act" means the Animals Act 1982.

### PRESCRIBED FEES

4. Where any provision in the Act or in any regulations made thereunder provides for the payment of a prescribed fee in respect of a particular matter, the fee to be paid shall be the fee set out in the Schedule hereto for that matter and shall be payable to, and receivable by, the Licensing Authority under section 19 of subsection (1) of the Act.

### REVOCATION OF THE ANIMALS (PRESCRIBED FEES) REGULATIONS 1982

5. The Animals (Prescribed Fees) Regulations 1982 are hereby revoked.
