PARLIAMENTARY BY-ELECTION FOR THE
CONSTITUENCY OF UBENIDE, BOE, YAREN
MENENG AND BUADA

The Returning Officer, Mr Kelly Deouri Emiu, notifies for general information that a Parliamentary By-Election will be held on Saturday, 21st February, 1998 and that the voting is compulsory for all electors, unless an elector:-

- 1) is absent from Nauru on polling day;
- 2) is seriously ill or infirm to the extent that he/she is precluded from attending a polling place to vote;
- 3) (in the case of a woman) is precluded by approaching maternity from attending to a polling place to vote; or
- 4) has some other valid and sufficient reason for not voting (to the satisfaction of the Returning Officer).
