PUBLIC SERVICE ACT 1998

- 1. It is hereby notified for general information that consequent to the coming into force of the Public Service Act 1998 with effect from 1st October 1998 the hours of duty, in terms of Section 34(1) of that Act, for officers and employees, other than teachers and shift workers and all officers and employees specified in paragraph 2 below shall, with effect from that date, be between the hours of nine o'clock in the morning and one o'clock in the afternoon and two o'clock in the afternoon and five o'clock in the afternoon on Monday, Tuesday, Wednesday, Thursday and Friday of each week.
