NAURU SUPERANNUATION BOARD ELECTION OF MEMBER

WHEREAS Section 7 (1) of the Superannuation Board consisting of three members appointed by Cabinet, one of whom shall be a person who is contributor within the meaning of the Act elected by contributors.
