Notaries Public (Fees) Rules 2001

IN EXERCISE of the powers conferred on me by Section 34 of the Legal Practitioners Act 1973, I hereby make the following Rules-

SHORT TITLE

1. These Rules may be cited as the Notaries Public (Fees) Rules 2001.

SCALE OF FEES

- 2. The fees chargeable by the notary public for discharging his duties under the provisions of the Act are those set out in the Schedule to these Rules.
- 3. These Rules replace the Notaries Public (Fees) Rules 1977.
