ELECTORAL ORDINANCE 1965-1992 SECTION 16

NOMINATIONS FOR PARLIMENTARY BY-ELECTION (CONSTITUENCY OF YAREN)

Intending candidates for By-Election in the Constituency of Yaren that-

- a) Nominations can validly be made only **after** the Rolls have been closed for the Constituency of Yaren (ie., after Saturday, 22nd June, 2002) and on or before nomination day (ie., on or before Saturday, 29th June, 2002).
- b) Nomination papers may be handed to the Returning Officer at Chief Secretary's office during normal working hours between 9:00am 5:00pm from Monday, 24th July Saturday, 29th June 2002 and also between 8:00am 1:00pm on Saturday 29th June, 2002. To assist intending candidates, the Returning Officer will also be available in the Chief Secretary's Office on those days. Nominations will close at 12:00 PM noon on 22nd June, 2002.
- Ordinance 1965-1992 and signed by (i) **at least two Electors** who are on the Roll for the Electoral Districts concerned (ie., the District in which the candidate intends to stand for election) and (ii) **by the candidate.** The intending candidates must also be an Elector whose name is on the Roll for the Electoral District concerned No nominations shall be valid unless they comply with the requirements of law.
- d) Nomination forms are available from the Chief Secretary's Office.
- e) Candidates who have been duly nominated, but wishing to withdraw their candidature may be so by notice in writing signed by them to the Returning Officer no later than 12:00pm noon on Saturday, 6th July, 2002.
