# ASSIGNMENT OF RESPONSIBILITY FOR THE **BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE BERNARD DOWIYOGO, BEING MINISTER FOR PUBLIC SERVICE, MINISTER FOR FOREIGN AFFAIRS, MINISTER FOR CIVIL AVIATION & TRANSPORT, MINISTER FOR INTERNAL AFFAIRS, MINISTER FOR ISLAND DEVELOPMENT INDUSTRY, MINISTER RESPONSIBLE FOR NAURU PHOSPHATE ROYALTIES TRUST, MINISTER RESPONSIBLE FOR AUDIT AND TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU.
