# CONSTITUTION OF NAURU ARTICLE 21

#### ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE RENE R HARRIS, MP BEING FOR:

- MINISTER FOR HEALTH & SOCIAL SERVICES
- MINISTER FOR EDUCATION, TRAINING & EMPLOYMENT
- MINISTER FOR PUBLIC SERVICE
- MINISTER RESPONSIBLE FOR NAURU PHOSPHATE ROYALTIES TRUST
- MINISTER FOR FOREIGN AFFAIRS
- MINISTER FOR CIVIL AVIATION
- MINISTER RESPONSIBLE FOR RONTEL
- MINISTER RESPONSIBLE FOR BANK OF NAURU

### CONSTITUTION OF NAURU ARTICLE 23

#### ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT
