17th May, 2006 - Constitution Day

26th October, 2006 - Angam Day

25th December, 2006 - Christmas Day

26th December, 2006 - Boxing Day

Whenever a day specified in sub-section (1) except Independence Day and Christmas Day falls on a Saturday or Sunday, the following Monday is a holiday.

Whenever Independence Day and Christmas Day falls on a Saturday or Sunday, the following Monday and Tuesday are holiday.
