NAURU POLICE FORCE ACT 1972-1987

REDUCTION IN RANK AS A RESULT OF DISCIPLINARY HEARING

BE IT KNOWN that any member of the Nauru Police Force, who is reduced in rank by the Commissioner as a result of a hearing before the Disciplinary Board, is ineligible to be promoted for a period of twelve months from the date of the reduction in rank.

Further, the member who has been reduced in rank is ineligible, and is therefore not to be considered for any higher duty assignments for twelve months from the date of the reduction in rank.

This order is retrospective and effective from 1st July 2005.
