## CONSTITUTION OF NAURU ARTICLE 21

### ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE GODFREY THOMA, M.P., BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE TWENTIETH DAY OF OCTOBER, TWO THOUSAND AND SIX UNTIL THE RETURN OF HIS EXCELLENCY HONOURABLE LUDWIG SCOTTY, M.P. PRESIDENT OF THE REPUBLIC OF NAURU.
