WHOLESALE PRICE OF PETROL – 30 JULY 2007

It is notified for general information that Cabinet has approved the following:-

1. Agrees to the wholesale commercial price for petrol to be \$1.55/litre, noting the cost of the period is \$0.79/litre. The difference is due to the \$0.60 excise on petrol, a \$0.02/litre charged by Utilities for unloading, a \$0.10/litre storage fee for the petrol and a newly imposed cantilever fee charged by RONPHOS of \$0.035/litre:
2. Agrees that the Bank of Nauru, Commercial Outlets and the public are to be advised of the change in the price of Petrol, while also being reminded that Cabinet has decreed, under the authority of the Price Control Act 2004, that a maximum margin of \$0.30/litre be applied to this price by commercial outlets.
