MODIFYING THE ‘CLOSED CENTRE’ ARRANGEMENT AT THE PROCESSING CENTRE BY INTRODUCING NEW CONDITIONS

1. Modifying the current “close camp” arrangements by introducing the following new conditions:
 - Cultural orientation program to be undertaken by all asylum seekers as a prerequisite before release into the community.
 - Movement within Nauru outside of the designated sites shall be under escort of security personnel, or other designated persons as authorised by the office of the Ministry for Foreign Affairs. Such outings to be limited and strictly monitored.
 - Designated buses will be the prescribed means of transport.
 - Those asylum seekers named at Annexure one for the alleged August incident will not be permitted any outings.
 - Asylum seekers breaking these conditions will be immediately banned from future outings.
2. The new arrangements shall be in addition to conditions existing under the current closed camp arrangements at Annexure one.
3. The new arrangements shall be trialled for a period of one month after which a review is to take place.
