In exercise of the powers vested upon it by Section 2 of the Anti-Money Laundering Act, 2004, the Cabinet has hereby notified the following activities for inclusion in the Schedule to the Act.

- 19. the collection, holding, cashing in, remitting and delivering cash as part of a business providing payroll services.
- 20. the conduct of alternative remittance which means a system or transaction carried out by a person whether or not that person is an authorised financial institution whereby that person accepts from a second person, at any place, cash, cheques or other instruments of payment or stores of value, and pays an equivalent in any form and by any means, directly and indirectly, at another place or places, to the second person or to a third person.
