WHOLESALE COMMERCIAL PRICE OF DIESEL – 30 JULY 2007

It is notified for general information that Cabinet approved the recommendation as follows:-

- 1. Agree to the Wholesale commercial price of \$1.38/litre, noting the cost price of the diesel is \$0.75/litre. The difference is due to the \$0.60 excise on diesel, a \$0.02/litre charged by Utilities for loading/unloading and a newly imposed cantilever fee charged by RONPHOS of \$0.0035/litre (which has been rounded up to \$0.01/litre to ensure this cost is passed onto consumers and associated administration charges are covered).
- 2. Agree that the Bank of Nauru, commercial outlets and the public be advised of the change in price of diesel, while also being reminded that Cabinet has decreed, with its authority under the Price Control Act, that a maximum margin of \$0.30/litre be applied to this price by commercial outlets.
