ELECTORAL ACT 1961-2007

ELECTORAL (PROXY VOTING) AMENDMENT REGULATIONS 2007

In exercise of the powers conferred upon it by Section 27A of the *Electoral Act 1961-2007*, The Cabinet has this day made the following regulations.

Short title and commencement

- **1.** (1) These Regulations may be cited as the Electoral (*Proxy Voting*) (*Amendment*) Regulations 2007.
 - (2) These Regulations come into force on publication in the Gazette.

Interpretation

2. In these Regulations, unless the contrary intention appears- "the principal Regulations" means the Electoral (Proxy Voting) Regulations 2004;

Amendment of Principal Regulations

- **3.** For Regulation 2(c), substitute
 - "(c) "Witness" under this Regulation means-
 - (i) an Officer of the Republic as specified in the First Schedule of these Regulations; or
 - (ii) any person or persons in a country other than Nauru appointed by the Chief Secretary by notice in the Gazette to be a witness for the purpose of these Regulations".
