#### NATIONAL DISASTER MANAGEMENT

It is notified for general information that Cabinet approved the following:-

- 1. A National Disaster Plan, the need for and benefits to Nauru in having a comprehensive National Disaster Plan that will establish the organizational structure, chain of command, procedures, responsibilities, as well as inform the development of related legislation that will enable Nauru to respond appropriately to all types of disasters;
- 2. The assigning of overall authority for all matters relating to National Disaster Management to the President;
- 3. The Minister for Transport & Telecommunications has been tasked with assisting and overseeing the planning and administration of National Disaster matters, and further the Ministerial responsibilities may be confirmed or re-assigned by the in-coming Government following the General Elections;
- 4. The designation of the Commissioner for Police as the official "National Focal Point" for all matters relating to National Disaster Management;
- 5. To establish and incorporate the National Disaster Management Office, Disaster Command Room and Communications Base in the new Police Headquarters currently being planned;
- 6. The establishment of a "National Working Group on National Disaster Management Planning", tasked to initially establish interim procedures relating to National Disaster Management and to primarily assist the National Focal Point in developing and finalizing the National Disaster Management Plan, and to be comprised of the following:-
