WHOLESALE COMMERCIAL PRICE OF DIESEL

It is notified for general information that Cabinet approved the following;

- The wholesale commercial price for diesel of \$1.70/litre following the 3rd January, 2008 shipment, noting the unloaded cost price of the diesel is \$0.94/litre. The difference is due to the \$0.60 excise on diesel, a \$0.02/litre charged by Utilities for unloading, a \$0.10/litre storage fee for the diesel and a newly imposed cantilever fee charged by RONPHOS of \$0.04/litre
- The Bank of Nauru, commercial outlets and the public are advised of the changes in price
 of diesel, while also being reminded that Cabinet has decreed, with its authority under the
 Price Control Act 2004 that a maximum margin of \$0.30/litres be applied to this price by
 commercial outlets.
- The commercial wholesale price will increase from \$1.59/litre to \$1.70/litre.
