POSITION : INFRASTRUCTURE MANAGER

SALARY/SCALE : \$6,920 pa (6.1)

PRIMARY PURPOSE OF POSITION:

The Infrastructure Manager is to provide continued management and maintenance of the health department plant and equipments that include genset, reverse osmosis unit, oxygen plant, hyperbaric unit, mortuary and the incinerator, and is also responsible for the maintenance and repair of all vehicles in the Health Department, building infrastructure of both hospitals (Public Health and RON hospital) and other medical/non medical equipments ensuring that these are maintained in working order.

The position is also responsible in the daily management of staff in coordinating and delegating tasks, while reporting to the Director of Administration.

DUTIES AND RESPONSIBILITIES:

- Assist the Director of Administration in preparations and sustainability of the Health Budget including other duties as assigned;
- Maintain weekly update on the database of inventory list of Health Department assets (medical and non medical) including health infrastructures and utilities systems;
- Coordinate with appropriate technical and mechanical services for continued maintenance of Health Department assets (medical and non medical) including health infrastructures and utilities systems;
- Provide a report of activities on a monthly basis;
- Responsible for procurement of health repairs & maintenance requirements and replenishments;
- Assist and ensure ongoing training and development of subordinates;
- Maintain weekly update of job card requests and requirements;
- Daily management of staff and monitoring of work performance;
- Maintain confidentiality of any information received in the work place at all times;
- Undertake quality assurance activities;
- Perform other duties as may be assigned by the Health Senior Management Team.
