# ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

KIEREN KEKE, M.P., BEING A MEMBER OF THE CABINET OF NAURU TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU, EFFECTIVE SECOND DAY OF NOVEMBER, TWO THOUSAND AND NINE, UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT.
