NAURU LANDS ACT 1976

LET BE KNOWN BY ALL AND SUNDRY that section 9 (2) of the Nauru Lands Act 1976, as amended, stipulates that no money shall be payable as surface rights capital payment or an advance cash royalty for phosphate, as the case may be in respect of subsequent leases of phosphate bearing land by the Republic, the Corporation or any other statutory corporation for use other than the mining of phosphate.

Furthermore section 10 (2) of the said Act stipulates that where any phosphate bearing land is leased to the Republic or a statutory corporation by a lease executed after the commencement of the Act, no rent shall be paid by the Lessee to the Lessor unless express provision to the contrary is contained in the lease.

Where express provision has been made in the lease to pay rent contrary to section 10 (2) of the Act the Cabinet, pursuant to powers vested in it by section 16 (1) of the Nauru Lands Act 1976, as amended, hereby order that the rent payable shall be in the same manner and rate payable for lease on non phosphate bearing or worked out phosphate bearing land in accordance with the provisions of the Third Schedule, as amended, namely:

- \$1.20 per square meter per annum as the standard rate
- \$2.40 per square meter per annum for expatriate housing or aerodrome, and
- \$3.60 per square meter per annum for profit-making

This order shall take effect fourteen days after the first sitting of Parliament after its publication in the Gazette unless revoked by Parliament within that time. The order shall remain in effect until the order is revoked by the Cabinet or is invoked into law by Parliament by way of amendment to section 10 and the Third Schedule of the Principal Act, the Nauru Lands Act 1976 as amended, whichever occurs first.
