SUCCESSION, PROBATE AND ADMINISTRATION ACT 1976 NOTICE UNDER SECTION 55 OF THE ACT DECEASED ESTATES

PERSONALTY ESTATE OF THE LATE ALF ITSIMAERA

The Curator of Intestate Estates has hereby determined that ALL Personalty Estate such as: Aerodrome Rentals, Land Rentals RONWAN interests, Royalties, Salaries & Final entitlements, passbook and all other residual funds (if any) of the late ALF ITSIMAERA goes to DIANA ITSIMAERA only.
