## ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

KIEREN KEKE, M.P., BEING A MEMBER OF THE CABINET OF NAURU TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU, EFFECTIVE EIGHTEENTH DAY OF SEPTEMBER, TWO THOUSAND AND NINE, UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT.
