a) Maximum wholesale prices for diesel and petrol

• Diesel: \$1.37 per litre; and

• Petrol: \$1.34 per litre.

b) Maximum retail margin for diesel and petrol

• Diesel: \$0.30 per litre; and

• Petrol: \$0.30 per litre.

This order shall remain in force until the next Prices Regulation Order relating to fuel prices is issued.
