### CALL FOR NOMINATIONS – TEACHER REGISTRATION AND CURRICULUM BOARD

The Teacher Registration and Curriculum Board is established by section 39 of the *Education* Act 2011. The principal purpose of the Board is to improve the quality of education in Nauru by overseeing the implementation of approved curricula and teacher registration.

The Department of Education now invites members of the public to nominate suitably qualified and experienced people for appointment to the Board under section 40 of the Act.

Section 40 provides as follows:

#### 40 Membership

- (1) The Board comprises 5 members appointed by Cabinet, of whom:
  - (a) at least 3 must have a bachelor's degree in any discipline; and
  - (b) at least 1 must be, at the time of the member's appointment, the parent of a school-age child; and
  - (c) 1 only must be a registered teacher.
- (2) Before appointing a person to the Board, Cabinet must:
  - publish in the Gazette a notice inviting members of the public to nominate, within 7 days after the publication of the notice, candidates for membership; and
  - (b) consider any nominations received.
- (3) Before appointing a person to the Board, Cabinet must be satisfied that the person is:
  - (a) of good character; and
  - (b) of strong integrity; and
  - (c) capable of performing the functions of a member of the Board in a competent and objective manner.
- (4) Except for the member mentioned in subsection (1) (c), a teacher or a person who is employed in the Department is not eligible for appointment as a Board member.

Nominations must be directed to the Secretary for Education, Government office, Yaren district, and must be received no later than 5:00pm on Wednesday, 19 October 2011. The nomination must be in writing and must set out in detail how the nominee meets the selection criteria. The person being nominated must indicate in writing that he or she agrees to being considered for appointment to the Board. No remuneration will be paid for serving as a member of the Board.
