PRICES REGULATION ACT 2008 PRICES ORDER

I Hon. Dr. Kieren Keke, M.P., Minister for Finance, acting with the advice of the Secretary for Finance and the approval of Cabinet, under Sections 5(3) and 6(1) of the Prices Regulation Act 2008, determine that, from the date this notice is published in the Gazette:

- the maximum wholesale price at which the diesel may be sold is \$1.40 per litre; and (a)
- the maximum wholesale price at which petrol may be sold is \$1.40 per litre; and (b)
- the maximum retail price at which diesel may be sold is \$1.70 per litre; and (c)
- the maximum retail price at which petrol may be sold is \$1.70 per litre. (d)

NOTES:

- 1. Under Section 5(1) of the Prices Regulation Act 2008, the Minister must give 21 days notice of his intention to make a a prices order. However, Section 5(3) of the Act allows the Minister to make a prices order without giving 21 days notice if he is satisfied that it is necessary or expedient to act without delay in order to ensure the fair distribution of declared goods amongst all members of the community.
- 2. A prices order may only be made in relation to goods that are declared goods for the purpose of the Price Regulation Act 2008. The Minister declared diesel and petrol to be declared goods by Gazette Notice No. 344/2008, published on 12 September 2008.
