# NOTICE Creation and abolition of offices

#### Public Service Act 1998, section 10

I, Hon. Sprent Dabwido M.P, Minister for the Public Service:

- (a) create the following positions in the Department of Parliament -

  - Executive Secretary to the Speaker and the Clerk (Level 3.2)
  - Accounts and Budget Officer (Level 5.3)
  - Executive Secretary to PAC and Hansard Officer (Level 5.1)
  - Assistant Clerk (Level 6.1)
  - Intern to PAC Secretary (Level 4.1)
  - Cleaning Supervisor (Level 2.1)
  - Cleaner (Level 1.1)
  - Deputy Parliamentary Counsel (Level 7.2) (second position)

(b) abolish the following offices in the Department of Parliament –

- Executive Secretary to the Speaker (3.2)
- Executive Secretary to the Clerk (3.2)
- Executive Secretary to PAC (3.2)
- Senior Librarian (5.3)

# (c) raise the classification of the following offices in the Department of Parliament –

- Director, Legal Publications Unit (from 5.3 to 6.1)
- Legal Publication Officer (from 4.1 to 5.1)
- Hansard Reporter (3 positions) (from 2.1 to 3.2)

The actions set out in paragraphs (a) to (c) above have effect from 1 July 2012. As a result of these actions, the Department of Parliament comprises the positions set out in the Schedule to this notice. I further direct that subsection 10(2) of the Public Service Act 1998 does not apply to the alteration of the classification of Hansard Reporters.
