# ADMINISTRATIVE ARRANGEMENTS ACT 2011 SECTION 4(1)

### RESTRUCTURE OF THE HOME AFFAIRS DEPARTMENT

I Hon. Shadlog Bernicke, M.P., Acting President of the Republic of Nauru, do hereby order that the Department of Home Affairs shall be restructured in the following manner:

- 1. The Lands and Survey Directorate formerly administered by the Minister for Home Affairs shall be transferred to the Department of Land Management and administered by the Minister for Land Management.
- 2. The Directorate of Post and Philately Office formerly administered within the Department of Chief Secretary shall be transferred to the Department of Home Affairs and shall be administered by the Minister for Home Affairs.
- 3. The Directorate of Tourism formerly administered within the Department of Commerce Industry and Environment shall be transferred to the Department of Home Affairs and shall be administered by the Minister for Home Affairs.
- 4. The Directorate of Youth Affairs formerly administered within the Department of Education shall be transferred to the Department of Home Affairs and shall be administered by the Minister for Home Affairs.
- 5. The Clean and Green Project formerly administered within the Department of Chief Secretary shall be transferred to the Department of Home Affairs and shall be administered by the Minister for Home Affairs.
- 6. The Directorate of Culture and Language is hereby formed and shall be administered by the Minister for Home Affairs.
- 7. The Directorate of Family and Community Services is hereby formed and shall be ministered by the Minister for Home Affairs.

### RESTRUCTURE OF THE LAND MANAGEMENT DEPARTMENT

I Hon. Shadlog Bernicke, M.P., Acting President of the Republic of Nauru, do hereby order that the Land Management Department shall be restructured in the following manner:

- 1. The Secretariat of Land Management is hereby formed within the Department of Land Management and shall be administered by the Minister for Land Management.
- 2. The Lands and Survey Directorate formerly administered by the Minister for Home Affairs shall be transferred to the Department of Land Management and administered by the Minister for Land Management.
- 3. The Land Registration Branch is hereby formed within the Lands and Survey Directorate as part of the Department of Land Management and shall be administered by the Minister for Land Management.
- 4. The Survey and Land Boundaries Branch is hereby formed within the Lands and Survey Directorate as part of the Department of Land Management and shall be administered by the Minister for Land Management.
- 5. The survey sections of Ronphos and Nauru Rehabilitation Corporation shall be abolished and the employees shall be transferred to the Lands and Survey Directorate.

#### RESTRUCTURE OF THE FINANCE DEPARTMENT

I Hon. Shadlog Bernicke, M.P., Acting President of the Republic of Nauru, do hereby order that the Warehouse Section that was formerly administered under the Department of Chief Secretary shall be transferred to the Department of Finance and administered by the Minister for Finance.
