**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT HON. AARON COOK, M.P., BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE WEDNESDAY SEVENTEENTH SEPTEMBER 2014 UNTIL THE RETURN OF EITHER HIS EXCELLENCY THE PRESIDENT HON. BARON DIVAVESI WAQA, M.P OR MINISTER ASSISTING THE PRESIDENT HON. DAVID ADEANG, M.P.
