I, HON. DAVID ADEANG MP, Minister for Justice and Border Control, acting under Part 3, s15 (5) of the Asylum Seekers (Regional Processing Act) 2012 as currently in force (the Act):

DELEGATE TO THE PERSON or persons from time to time holding the position, or for the time being occupying or performing the duties of the position, of Director, Connect Settlement Services, ALL POWERS AND FUNCTIONS that I have as the guardian of all unaccompanied children who arrive in Nauru EXCEPT my powers and functions as a guardian of an unaccompanied child insofar as thy relate to:

- 1) the transfer or return or resettlement of a child to another country; or
- 2) the giving of consent for the marriage or adoption of a child; or
- 3) the withholding or withdrawing of medical life support.

I am satisfied that the person or persons from time to time holding the position of Director, Connect Settlement Services or for the time occupying or performing the duties of that position, are persons who fulfil the criteria under s15(6)(a) and (b) of the Act.

This delegation supersedes any previous delegation and comes into force as of the date of signature.
