Cabinet makes the following regulations under section 42 of the Fisheries Act 1997:

1. Citation

These Regulations may be cited as the *Fisheries (PNA Third Implementing Arrangement)* (Amendment) Regulations 2015.

2. Commencement

These Regulations commence on the day on which they are notified in the Gazette.

3. Amendment of Fisheries (PNA Third Implementing Arrangement) Regulations 2009

The Fisheries (PNA Third Implementing Arrangement) Regulations 2009 are amended by the provisions of these Regulations.

"Transshipment" means the transfer of any or all of the fish on board a boat onto another boat, either directly or by off-loading the fish from the boat onto the shore and thence immediately onto another boat.

Cabinet makes the following regulations under section 38(q) of the Agricultural Quarantine Act 1999:

1. Citation

These Regulations may be cited as the Agricultural Quarantine (Fees) Regulations 2015.

2. Commencement

These Regulations shall be taken to have commenced on 31 July 2015.

3. Definitions

All terms and phrases used in these regulations has the same meaning as in the *Agricultural Quarantine Act* 1999.

4. Fees

In relation to the attendance of an officer at a port, airport or other quarantine place or premises during hours specified in column 1 of the Schedule, the fee payable per officer is specified opposite in column 2.
