IN ACCORDANCE with Section 56 (2) of the Electoral Act 2016, I, hereby publish the particular of the writ issued by the Honourable Speaker on the 11th day of June 2016: and the dates of the nomination, withdrawal and the closing of the Roll for the General Elections:

- 1. On 11th June, 2016 Honourable Ludwig Scotty MP, Speaker of Parliament, issued a writ for a general election to me as Electoral Commissioner under section 56(1) of the Electoral Act 2016.
- 2. The polling day for the General Election is Saturday 09th July, 2016. Polling will open at 9:00am and close at 6:00pm
- 3. The nomination day for the General Election is Saturday 25th June, 2016. Candidates may be nominated from 9:00am Sunday 19th June, 2016 until 5:00pm on Saturday 25th June, 2016.
- 4. In accordance with section 58 of the Electoral Act, 2016, a person who has been nominated as a candidate may withdraw by notice in writing given to the Electoral Commissioner no later than 12:00 midday on Friday 01st July, 2016.
- 5. The Roll will be closed for the General Election on Saturday 18th June, 2016 at 5:00pm
