- 3. The Roll for the District that is entered in the Register of Births maintained under Section 6(1) of the *Births, Deaths and Marriages Act 1957*; or
- 4. In any register or record of births certified under Section 6 (3) of the *Births, Deaths and Marriages Act 1957* as his or her place of birth; or

The Roll in respect of a District with which the Electoral Commissioner has certified in accordance with Schedule 3 that he or she has substantial connection through:

- 5. Nauruan custom, customary links and affiliation;
- 6. Birth by either his or her parent in that District;
- 7. The registration for any electoral purposes of either his or her parent in that District;
- 8. His or her spouse being born in that District.
