Owners or licensees of the abovementioned businesses must immediately cease their business operations.

Under Section 17 of the Business Licences Act 2017, a person who operates a business on an expired licence must pay the following penalties on lodging an application for renewal:

- within 1 month from the date of the expiry of the licence \$1,000;
- 2 months from the expiry date of the licence \$3,000; or
- 3 months or more from the expiry date of the licence \$10,000

Owners or licensees must show cause to me within 14 days of this Notice why such licence must not be cancelled.

A licence may not be cancelled if the owner or licensee takes remedial measures to my satisfaction within 21 days of this Notice.

If an owner or licensee fails to show cause, such business licence will be cancelled from the Register of Business Licences.
