Cabinet makes the following Regulations under *Section 12* of the *Customs Tariff Act 2014*:

1 Citation

These Regulations may be cited as the *Customs Tariff (Alteration to Tariff) Regulations 2020*.

2 Commencement

These Regulations commence on the day they are notified in the Gazette.

3 Alteration of Schedule 1

Schedule 1 is amended by:
