ADMINISTRATIVE ARRANGEMENTS ORDER 2020 SL No. 1 of 2020

I, Lionel Rouwen Aingimea, M.P. and President of the Republic of Nauru, pursuant to Section 4(1) of the *Administrative Arrangements Act 2011*, make the following **Administrative Arrangements Order** with effect from 15 January 2020:

- 1. Each Minister specified in Column 1 of the Schedule to this Order is responsible for the administration of the written law, or part of the written law specified opposite in Column 3 of the Schedule.
- 2. Each Department or part of a Department specified in Column 2 of the Schedule is responsible to the Minister specified opposite in Column 1 for the administration of the law, or part of the written law specified opposite in Column 3.
- 3. This Order supersedes the *Administrative Arrangements Order No. 2 of 2011*.
