Cabinet makes the following Regulations under Section 117 of the Motor Traffic Act 2014:

1 Citation

These Regulations may be cited as the Motor Traffic (Traffic Infringement Notices) (Amendment) No. 2 Regulations 2020.

2 Commencement

These Regulations come into effect on the day they are notified in the Gazette.

3 Amendment of Motor Traffic (Traffic Infringement Notices) Regulations 2018

The Motor Traffic (Traffic Infringement Notices) Regulations 2018 are amended by the provisions of these Regulations.

4 Amendment to Regulation 6

Regulation 6 is deleted and substituted as follows:

6 Prescribed Traffic Infringement Notice

For the purposes of *Section 117(2)(c)* of the Act, the Traffic Infringement Notice which a Police officer may serve to an offender shall be in: (a) the prescribed form in Schedule 2; or

(a) the prescribed form in Schedule 2; or

(b) the prescribed form in Schedule 2A.
