## **SUCCESSION, PROBATE AND ADMINISTRATION ACT 1976**

In Accordance with Section 37 of the Succession, Probate and Administration Act 1976 (the Act), the Curator of Intestate Estates with respect of the above named estates:-

- (1) Will accept services of notices and proceedings
- (2) Will execute leases of all or any of the real estate of the above persons to the RONPHOS Corporation for the mining of phosphate therefrom, and
