Coffee, teas and cocoa and substitutes therefor; coffee substitutes; rice; tapioca; sago; flour; preparations made from cereals; bread; pastries; baked goods, confectionery, chocolate and desserts; edible ices; sugars, natural sweeteners, sweet coatings and fillings, bee products; honey; treacle; yeast; baking-powder; edible salt; seasonings; condiments; food flavourings; mustard; vinegar; sauces; spices; ice; pizza; pies; popcorn; sandwiches; pasta; ice creams; sorbets; processed grains, starches, and goods made thereof, baking preparations and yeasts; chocolate based drinks; coffee based drinks; tea-based beverages; iced tea; pralines; chewing gums; cereal based snack foods; candies.

Beers; mineral waters; aerated waters; non-alcoholic beverages; fruit beverages and fruit juices; syrups for making beverages; preparations for making non-alcoholic beverages; energy drinks.

Alcoholic beverages [except beers]; spirits and liquors; wine; cider; pre-mixed alcoholic beverages; preparations for making alcoholic beverages; alcoholic energy drinks.
