## ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

MARTIN HUNT, M.P OR HIS EXCELLENCY THE PRESIDENT, HON. RUSS JOSEPH KUN, M.P.
