## **ADMINISTRATIVE ARRANGEMENTS ORDER 2024**

## SL No. 3 of 2024

- I, **Hon. David W.R. Adeang, M.P.**, President of the Republic of Nauru, pursuant to Section 4(1) of the *Administrative Arrangements Act 2011*, make the following Order with effect from 30 October 2023:
  - 1. Each Minister specified in Column 1 of the Schedule to this Order is responsible for the administration of the written law or part of the written law specified in Column 3 of the Schedule.
  - 2. Each Department, Office or instrumentality or part of a Department, Office or instrumentality specified in Column 2 of the Schedule is responsible to the Minister specified in Column 1 for the administration of the law or part of the written law specified in Column 3 of the Schedule.
  - 3. Each Deputy Minister may be assigned responsibilities under the *Deputy Ministers Act 2023* by the President, of the written law or part of the written law specified in column 3 of the Schedule.
  - 4. This Order revokes the *Administrative Arrangements Order* 2022.
