The Department of Justice, Lands and Survey and Community Affairs hereby inform the public that the High Court of Niue will be convened in the months of March and November 2016 at the Conference Room of the Niue Public Service Building at Fonuakula, Alofi.

The High Court Sittings for the month of March 2016 will be convened on the week commencing Monday 7th March to Friday 11th March 2016.

The High Court Sittings for the month of November 2016 will be convened on the week commencing Monday 14th November to Friday 18th November 2016.

All Court Sittings will commence at 8.30am daily.

The Judge of the High Court of Niue will travel to Niue from New Zealand to preside over all applications that are to be listed for hearing in the Niue Government Gazette and in the Civil and Criminal Court Listings for the Sittings in March and November 2016.

All applicants or persons with interest in any applications who want their applications to be listed for hearing in the Niue Government Gazette and in the Civil and Criminal Court Listings for March and November 2016 should now enquire to the Department through the respective High Court Registry Divisions.
