# AN ORDINANCE

*Relating to Duties of Customs.*

**B**E it enacted by the Lieutenant-Governor of the Territory of Papua, with the advice and consent of the Legislative Council thereof, as follows:—

**1.** (1) This Ordinance may be cited as the *Customs* Short title and citation.  
*Tariff, 1919.*

(2) The *Customs Tariff, 1915*, is in this Ordinance referred to as the Principal Ordinance.

(3) The Principal Ordinance, as amended by the *Customs Tariff, 1916*, and this Ordinance may be cited as the *Customs Tariff, 1915-1919.*

**2.** The Second Schedule to the Principal Ordinance is amended as set out in the Schedule to this Ordinance Amendment of Tariff. except as to anything done before the commencement of this Ordinance and except so far as relates to any arrears

of duty and except so far as may be necessary for the purpose of supporting or continuing any proceeding heretofore taken or to be taken after the commencement of this Ordinance and Duties of Customs are hereby imposed in accordance with the Second Schedule as so amended.

Date from which new duties, &c., are to commence.

3. (1) Subject to this section, where by this Ordinance—

- (a) any duty is imposed on any article, or
- (b) the duty on any article is decreased, or
- (c) any article is declared free,

the duty or decrease of duty shall be deemed to have been imposed and any article declared free of duty shall be deemed to have been free, as on and from the fourth day of July, One thousand nine hundred and nineteen, at ten o'clock in the forenoon, reckoned according to the standard time in force in the Territory of Papua and this Ordinance shall be deemed to have come into operation at that time.

Passed in Council this fourth day of July, in the year of Our Lord One thousand nine hundred and nineteen.

#### SCHEDULE.

That the Second Schedule to the *Customs Tariff, 1915-1916*, be amended as hereunder set out, and that on and after the fourth day of July, One thousand nine hundred and nineteen, Duties of Customs be collected in pursuance of the "Customs Tariff" as so amended.
