#### 1. INTERPRETATION.

A reference in this Regulation to a form by number shall be read as a reference to a form so numbered in Schedule 1.

### 2. PRESCRIBED FORMS.

- (1) The form of application for the purpose of Sections 40 and 45 of the Act in respect of the registration and renewal of registration as an Accountant in Employment shall be in Form 1 of Schedule 1.
- (2) The form of application for the purpose of Section 40 of the Act in respect of registration as a Registered Public Commercial Book-keeper, Registered Public Accountant, Registered Company Auditor and Registered Liquidator shall be in Form 2 of Schedule 1.
- (3) The form of application for the purpose of Section 45 of the Act in respect of renewal of registration as a Registered Public Commercial Book-keeper, Registered Public Accountant, Registered Company Auditor and Registered Liquidator, shall be in Form 3 of Schedule 1.
